

- Commissions** Consignor receives a commission of 50% of selling price of items sold within their consignment period in the store, and of up to 70% of realized price for auctioned items.
- Pricing** Pricing and markdowns are determined by, and are at the discretion of, T2T. Items are subject to a graduated fee, which is not considered part of the "selling price."
- Consignment Period** 60 days for items less than \$60 ("60 under 60").  
120 days for items \$60 or more.
- Markdowns** Items are marked down according to a schedule set by T2T.
- Expiration** Unsold items expire at the end of their Consignment Period.

**Drop-off/Item Intake**

- All items must be: clean, in good repair, not chipped or damaged, and worth at least \$10.
- Tables To Teapots (T2T) reserves the right to reject any item.
- Any items requiring cleaning, polishing, repair, or other work prior to sale will incur a fee (deducted from the Consignor account) OR will be returned to Consignor (items must be picked up within seven (7) days of Call-For-Pickup).
- T2T will donate/discard rejected items unless claimed by Consignor within seven (7) days of Call For Pick-up (if call requested).

**Price Schedule and Expiration**

- Item pricing is set by T2T, based on our research and the market.
- The following is T2T's typical markdown schedule, which is subject to change without notice:

- **Audio Equipment & Media and Seasonal Items**
  - Regardless of initial price, audio equipment is marked down once at 30 days and then never expires.
  - All media (LPs/CDs) are marked down once at 30 days and then expire after nine (9) months.
  - Seasonal items are marked down when and as T2T determines the seasonal market has waned.
- Expired items may be claimed by Consignor within 10 days before their final expiration date—Consignor is responsible for collecting items within the store and for bringing their own packing materials and containers.
- No commissions are paid on expired items. Unclaimed expired items may be sold at "clearance" pricing, or donated, or discarded if not donatable—to make room for more of your excellent stuff!

**Commissions and Payments**

- Checks are issued the 15th of each month for the *prior* month's sales.
- Checks are held for pick-up at the store; there is a \$10 yearly fee to have checks mailed.
- Checks are issued only when monthly payment due to Consignor is \$20 or more; if Consignor's monthly payment due is less than \$20, it is available as store credit.
- Consignor may request a check be issued if accrued commissions total \$20 or more.
- Checks not cashed within six (6) months of date of issue are void. The reissuing fee per check is \$25.

**Expired Items**

- Consignor may pick up unsold items within 10 days *prior* to item expiration date.
- Consignor is responsible for tracking items' expiration status on the T2T Consignor Portal.
- No commission will be paid on expired items.
- Items unclaimed by their expiry date become property of T2T with no notice, payment, or liability.
